Overall responsibilities include:

- Providing information technology/computer network support for all County departments and offices

**EMPLOYEES:** The Jo Daviess County GIS/IT Department employs five (5) full-time employees.

#### **BUDGET:**

The Jo Daviess County GIS/IT Department uses two operating budgets – the GIS Automation Fund budget for GIS expenses and the Information & Communication Technology budget in the County General Fund for ITrelated expenses. The total GIS Automation Fund operating budget for the Fiscal Year 2024 is \$293,096. The total Information & Communication Technology operating budget for the Fiscal Year 2024 is \$489,824.

#### **BOARDS:**

The Jo Daviess County GIS/IT Department reports to the County Administrator, the Jo Daviess County Board and the Jo Daviess County Board Information & Communication Technology Committee. A listing of committees and committee members is attached as Exhibit 2.


