

JO DAVIESS COUNTY, ILLINOIS

A RESOLUTION
TO ESTABLISH CERTAIN FEES CHARGED BY THE JO DAVIESS COUNTY
HIGHWAY DEPARTMENT

WHEREAS, the County Board of the County of Jo Daviess has authority pursuant to Illinois law to set reasonable fees for services, and;

WHEREAS, the County Board of the County of Jo Daviess has adopted certain ordinances in the Jo Daviess Code of Ordinances, including Title 6, County Roads and Transportation, that are enforced by the Jo Daviess County Highway Department, and;

WHEREAS, Jo Daviess County engaged the services of Lindgren, Callihan, Van Osdol and Co., Ltd. (LCV) to conduct a cost study to account for the actual cost of providing various services; and

WHEREAS, LCV completed a cost study for Jo Daviess County in accordance with OMB Circular A-87, for the period ended November 30, 2008, A Study of Sheriff, County Clerk/Recorder, Animal Control, Public Health, Building & Zoning, Highway, and Geographic Information Systems (GIS) Fee Services for Jo Daviess County, Illinois, a copy of which is on file in the County Clerk/Recorders Office in the Courthouse and available for review during regular business hours; and;

WHEREAS, the Finance, Tax, and Budgets Committee has reviewed the cost study and has considered the recommendations of the County Highway Engineer and the Public Works Committee and recommends that certain fees should be established and charged by Highway Department, and;

WHEREAS, it is desirable to have the Jo Daviess County Highway Department fee structure established as a resolution; and

WHEREAS, the Jo Daviess County Board has reviewed this resolution and the cost study and concurs with the recommendations of the Finance, Tax, and Budgets Committee.

NOW, THEREFORE, BE IT RESOLVED BY THE COUNTY BOARD OF JO DAVIESS COUNTY, ILLINOIS, THAT:

SECTION 1. The following fees shall be established and charged by the Jo Daviess County Highway Department:

- A. The fee for overweight permits shall be \$60.00 for each permit.
- B. The fee for driveway permits shall be \$150.00 for each permit.
- C. The fee for utility permits shall be \$75.00 for each permit.

BE IT FURTHER RESOLVED that this resolution supersedes any other resolution and becomes effective July 1, 2010.
