

FREEDOM OF INFORMATION ACT POSTING

The purpose of the Freedom of Information Act ("FOIA") is to ensure that all persons are entitled to full and complete information regarding the affairs of government, and the official acts and policies of those who represent them as public officials (5ILCS 140/1). Pursuant to FOIA, the following information is made available to the general public:

BACKGROUND INFORMATION

PURPOSE: The Jo Daviess County Geographic Information System (GIS) & Information Technology (IT) Department is responsible for providing GIS services and products for use by County employees and officials as well as the general public; administration and continued development of the Jo Daviess County Government website; and information technology/computer network support for all County Departments and Offices. Overall responsibilities include:

- Providing GIS services and products to County employees and officials as well as the general public
- Administration and continued development of the Jo Daviess County website
- Providing information technology/computer network support for all County departments and offices

EMPLOYEES: The Jo Daviess County GIS/IT Department employs five (5) full-time employees.

BUDGET: The Jo Daviess County GIS/IT Department uses two operating budgets – the GIS Automation Fund budget for GIS expenses and the Information & Communication Technology budget in the County General Fund for IT-related expenses. The total GIS Automation Fund operating budget for the Fiscal Year 2016 is \$189,671. The total Information & Communication Technology operating budget for the Fiscal Year 2016 is \$175,558.

BOARDS: The Jo Daviess County GIS/IT Department reports to the County Administrator, the Jo Daviess County Board and the Jo Daviess County Board Information & Communication Technology Committee. A listing of committees and committee members is attached as Exhibit 2.


COPY COSTS: Except when a fee is otherwise fixed by statute, the Jo Daviess County GIS/IT Department will charge the following rates for copies of requested records:
