Dear Jo Daviess County Resident,

The Jo Daviess County Board has recently solicited bids for its Municipal Electric Aggregation Program renewal, and we are pleased to announce that the County has selected FirstEnergy Solutions Corp. as the supplier of choice for the aggregation program. The competitive rate that we are able to provide to the residents of Jo Daviess County is fixed at 7.31 cents per kWh. The current ComEd Price to Compare is 7.596 cents per kWh* (plus a charge for Purchase Electricity Adjustment which fluctuates each month). This program commences with your September 2014 billing cycle and continues through your September 2017 billing cycle.

Electric Space Heat customers have also been included in the aggregation. ComEd Space Heat customers are now charged the same rate as non-Space Heat customers.

If you have any questions, please call FirstEnergy Solutions toll-free at 1-888-651-5200, Monday through Friday, 7 a.m. to 4 p.m., CST. Although the Jo Daviess County is offering this program, we ask that you direct all your aggregation questions to Rock River Energy Services, Co. at 815-732-4603.

Please note this rate is for the energy supply only and ComEd will continue to deliver your electricity. You will continue to receive a single, easy-to-read bill from ComEd with your FirstEnergy Solutions charges included and you will continue to make payments directly to ComEd. The bill will also include the ComEd delivery charges and taxes. ComEd will continue to deliver your service and respond to any disruptions.

This letter is notifying you that you will be automatically included in the aggregation program. No action is needed to participate. If you are not already participating, you will now be included, unless you return the attached "opt-out" form by July xx, 2014. **There is no cost for enrollment and you will not be charged a switching fee.** Since you are a new member, you will see your fixed price from FirstEnergy Solutions after your enrollment has been completed and your switch has been finalized – approximately 60 days, depending upon your meter read date. You are not obligated to participate in the Jo Daviess County electric governmental aggregation program.

After you become a participant in this governmental aggregation program, ComEd will send you a letter confirming your selection of FirstEnergy Solutions as your electric generation provider. As required by law, this letter will inform you of your option to cancel your contract with FirstEnergy Solutions within seven days of its postmark. **To remain in the Jo Daviess County electric governmental aggregation program, you don't need to take any action when this letter arrives.**
