

Sign Permit Fees:

Installation of new sign:

150 or more square feet ----- \$100.00

Annual fees:

Under 150 square feet ----- None
150-300 square feet ----- \$ 50.00
Over 300 square feet ----- \$100.00

(Annual fees should be calculated on a per structure basis, with a maximum of four (4) faces per structure)

ACTION TO CORRECT A VIOLATION

When any action is taken to correct a violation of any kind the fee will be increased by 50%.
